BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The total of ~~\$12,250~~ \$12,750 \$15,000 is hereby appropriated from Neighborhood Development Funds (NDF) in the following manner: \$5,000 from District 13; \$2,500 from District 14; \$1,000 each from Districts 24, 15, 12, 25; \$500 each from Districts 16, 23; \$250 each from Districts 8, 9, 4, 21, 22, 5, 6, 7, 17, 20; to the Louisville Metro Parks Department for operating expenses for the Forest Fest Annual Bluegrass Festival to be held at the Jefferson Memorial Forest.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
