AN ORDINANCE APPROPRIATING \$2,500 \$4,000 \$7,750 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 FROM DISTRICT 7; AND \$1,000 EACH\_FROM DISTRICTS 9 AND 15; AND \$500 EACH FROM DISTRICTS 2, 4, 10, 12, AND 24; AND \$250 EACH FROM DISTRICTS 3, 5, 6, 8, 13, 17, AND 21; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO POORCASTLE FESTIVAL, INC. FOR THE ANNUAL POORCASTLE FESTIVAL (AS AMENDED). BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$2,500 \$4,000 \$7,750 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$1,500 from District 7; and \$1,000 each from Districts 9

and 15; and \$500 each from Districts 2, 4, 10, 12, and 24; and \$250 each from Districts 3, 5, 6, 8,

<u>13, 17, and 21;</u> through the Office of Management and Budget, to Poorcastle Festival, Inc. for the annual Poorcastle Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
