BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$8,250~~\$10,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 15; \$1,500 from District 25; \$1,000 from District 2425; \$500 each from Districts 5, 6, 10, 12,

13, 14, 20, 21, 22; and \$250 each from Districts 2, 3, 4, 7; through the Office of Management and Budget, to The Young Men's Christian Association of Greater Louisville for programming expenses associated with the Together 4 Teens breakfast.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
