**A RESOLUTION AUTHORIZING THE MAYOR'S SIGNATURE ENTERING INTO AN AGREEMENT WITH THE COMMONWEALTH OF KENTUCKY TRANSPORTATION CABINET DEPARTMENT OF HIGHWAYS CONCERNING A PROJECT FOR THE INSTALLATION AND MAINTENANCE OF THE STREETScape ON E. MAIN STREET BETWEEN CLAY AND JACKSON STREETS.**

**WHEREAS**, the Commonwealth of Kentucky, Transportation Cabinet Department of Highways ("Department") and the Louisville-Jefferson county Metro Government ("Metro Louisville") desire to install aesthetic lighting, sidewalk furniture, and new trees as part of streetscape improvements ("project") on East Main Street, in Metro Louisville between Clay and Jackson Streets, from mile point 17.139 to mile point 17.343; and

**WHEREAS**, the Department intends to construct and install the project and then transfer ownership, responsibility, and maintenance to Metro Louisville.

**NOW THEREFORE BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** That the Mayor is hereby authorized to enter into an Agreement with the Commonwealth of Kentucky Transportation Cabinet Department of Highways concerning a project for the installation and maintenance of the streetscape on E. Main Street between Clay and Jackson Streets.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
