AN ORDINANCE **APPROPRIATING** \$8.000 IN DISTRICT NEIGHBORHOOD DEVELOPMENT **FUNDS** TO **METRO PARKS DEPARTMENT** FOR VARIOUS ACTIVITIES AND EVENTS TO BE HELD IN COMMUNITY CENTERS THROUGHOUT **DISTRICT 6**

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$8,000 is hereby appropriated from District 6 Neighborhood Development Funds to Metro Parks Department for various activities and events to be held in community centers throughout District 6.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
