BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$14,250 \$17,250 \$17,500 is hereby appropriated from District Neighborhood Development Funds as follows: \$5,000 from District 12; \$3,000 each from Districts 14, 13, 25; \$1,000 each from Districts 15, 24; \$500 each from Districts 4, 21, 3; \$250 from District 3; to Metro Parks for expenses associated with the 2015 Riverview Park Independence Festival.
