**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of

Kentucky Transportation Cabinet to accept additional funding of \$300,000 for construction of a paved multi-use trail, drainage improvements and signage for the Louisville Loop section along Shelbyville Road between Old Shelbyville Road and North Beckley Station Road.
