**Section I:** That the zoning of the property located at 13705 Aiken Road containing 1.90 acres, and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 13ZONE1026, is hereby changed from M-2 Industrial to C-M Commercial Manufacturing; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 13ZONE1026.
