**AN ORDINANCE CLOSING TWO ALLEYS BETWEEN 7<sup>TH</sup> AND 8<sup>TH</sup> STREETS AND GARLAND AVENUE AND BRECKINRIDGE STREET CONTAINING 0.22 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 14STREETS1024).**

WHEREAS, the Louisville Metro Planning Commission, as set forth in the minutes and records of Case No. 14STREETS1024, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that two alleys between 7<sup>th</sup> and 8<sup>th</sup> Streets and Garland Avenue and Breckinridge Street containing 0.22 acres and being in Louisville Metro be closed as said closings are in compliance with the guidelines, principles and objectives of the Comprehensive Plan; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in Case No. 14STREETS1024 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records;

**Now therefore be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government as follows:**

**Section I:** The two alleys between 7<sup>th</sup> and 8<sup>th</sup> Streets and Garland Avenue and Breckinridge Street containing 0.22 acres and being in Louisville Metro as more particularly described in the minutes and records of the Planning Commission in Case No. 14STREETS1024 and as shown on the attached plat be closed, subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

**Section II:** This Ordinance shall take effect upon its passage and approval.
