BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$17,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$12,500 from District 8; and \$5,000 from District 9; through the Office of Management and Budget, to Highland Commerce Guild Graffiti Abatement and Cleanup Program to fund graffiti removal along commercial corridors.
