**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$6,250 is hereby appropriated from District Neighborhood Development Funds as follows: \$2,500 from District 12; \$1,500 from District 11; \$1,000 each from Districts 9, 14; \$250 from District 16; through the Office of Management and Budget, to Stage One: The Louisville Children's Theatre, Inc., for costs associated with the production of "Harold and the Purple Crayon" including leasing the Bomhard Theatre at the Kentucky Center for the Arts.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
