AN ORDINANCE APPROPRIATING \$6,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,750 FROM DISTRICTS 12, 5; \$750 FROM DISTRICT 14; \$500 EACH FROM DISTRICTS 6, 1, 25; \$250 FROM DISTRICT 13; TO METRO PARKS FOR THE URBAN WILDERNESS CANOE ADVENTURE TO BE HELD OCTOBER 3RD AT SHAWNEE PARK AND OCTOBER 4TH AT RIVERVIEW PARK.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,750 each from Districts 12, 5; \$750 from District 14; \$500 each from Districts 6, 1, 25; \$250 from District 13; to Metro Parks for the Urban Wilderness Canoe Adventure to be held October 3rd at Shawnee Park and October 4th at Riverview Park.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.
