FOR EXPENSES ASSOCIATED WITH HOSTING ITS BIRDS, BREWS AND BBQ FUNDRAISER. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of $\$ 5,001 \$ 5,101 \$ 7,551$ is hereby appropriated from Neighborhood Development Funds in

the following manner: $\$ 2,001$ from District 10 ; and $\$ 500$ each from Districts $4,6,9,12,13,14,15$, and 24 , and $25 ; \$ 250$ each from Districts 1, 3, and 5; \$200 from District 2; and \$100 from District 7; through the Office of Management and Budget, to Louisville Nature Center, Inc. for expenses associated with hosting its Birds, Brews and BBQ fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
