Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:

**SECTION I:** Part I. J. Public Works & Assets of Ordinance No. 107, Series 2013 is hereby amended as follows:

**SECTION II:** Louisville Metro Government and Commonwealth of Kentucky Transportation Cabinet both wish to enter into an agreement to move forward with the agreement for Railroad Crossing/Road Closures - Norfolk Southern Railroad as listed in Section I of this Ordinance.
