AN ORDINANCE APPROPRIATING \$9,479 AS FOLLOWS: \$6,979 FROM DISTRICT 8 AND \$2,500 FROM DISTRICT 4 NEIGHBORHOOD DEVELOPMENT FUNDS, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE HIGHLAND COMMUNITY MINISTRIES, INC. FOR "FEEDING THE HUNGRY" PROGRAM. (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$ \$9,479 is hereby appropriated as follows: 6,979 from ~~the~~ District 8 and \$2,500 from District 4 Neighborhood Development Funds, through the Office of Management and Budget, to the Highland Community Ministries for its "Feeding the Hungry" program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No. 290, Series 2011.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
