FOR PROGRAMMING EXPENSES ASSOCIATED WITH PROJECT STAND DOWN AND THE "GIVE-A-JAM" EVENT (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$12,500~~ \$12,750 \$15,000 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$5,000 ~~\$6,000~~ from District 24; \$1,000 each from District 9 and 12; \$750 from District 14; \$500 each from Districts 2, 4, 7, 8, 13, 15, 17, and 21; and \$250 each from Districts 1, 3, 6, 10, 16, 17, 20, 22, 23 and 25; through the Office of Management and Budget, to The Coalition for the Homeless, Inc. for programming expenses associated with Project Stand Down and the “Give-A-Jam” event.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
