and Budget, to Kentucky Shakespeare <del>Festival,</del> Ir	nc., for costs associated with performances of Shakespeare in the Park.
SECTION II: The Council has determined the fun	nds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Cour	ncil's Policies and Procedures as adopted and effective at the date of
passage of this Ordinance.
