BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** The appropriation to the Office of Management and Budget in the second round of American Rescue Plan funding [Ordinance No. 168, Series 2021] is hereby amended as set forth in the amended Schedule A, attached hereto, and is approved for Fiscal Year 2022-2023.

**SECTION II:** Any unspent appropriated funds remaining in LAT-0057 Premium Pay - Component Units/External Agencies shall be transferred to LAT-0059 Compliance and Reporting to restore appropriations transferred and expended for Premium Pay.

**SECTION III:** The appropriation to the Department of Public Health and Wellness in the first hundred days of American Rescue Plan funding [Ordinance No. 090, Series 2021] is hereby amended as set forth in the amended Schedule A, attached hereto, and is approved for Fiscal Year 2022-2023.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
