**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept funding of \$120,000 to conduct an engineering study and structural inspection to the develop a preservation plan to guide the repair, rehabilitation and maintenance of the Tyler Park/Baxter Avenue Bridge.
