BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$6,250~~ \$12,750 is hereby appropriated from Neighborhood Development

Funds, in the following manner: \$1000 each from Districts 4, 2, 9, 12, 15, 20, and 22; \$500 each from Districts 1, 3, 5, 7, 10, 14, 16, 17, 23, 24, and 25; \$250 from District 13; through the Office of Management and Budget, to the Waterfront Development Corporation for costs associated with the Louisville Waterfront 4th of July.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
