### **BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** This Ordinance amends Ordinance 141, Series 2014 which appropriated \$15,500 including \$966.66 for Waterfront Development Corporation rental fees; through the Office of Management and Budget, to Harbor House of Louisville, Inc., for program expenses associated with the Ken-Ducky Derby.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.
