NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS: **SECTION I:** The Mayor is hereby authorized to execute and furnish all required documents, including a memorandum of agreement, as may be required by KOHS for the furtherance of the above referenced project and to act as the authorized correspondent for said project. **SECTION II:** The Mayor is hereby authorized to accept up to \$277,000 from the Kentucky Office of Homeland Security to purchase a rehab and response vehicle to supplement LMPD's chemical, radiological, and nuclear response capabilities. SECTION III: This Resolution shall become effective upon its passage and approval or otherwise becoming law.
