**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$8,250~~ \$12,500 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$2,500 from District 15; \$1,000 each from Districts 13, 24, 25, 14; \$500 each from Districts 21, 12, 2, 4, 5, 7, 8,

16, 17, 20, 22; \$250 from Districts 3, 10; through the Office of Management and Budget, to The YMCA of Greater Louisville for expenses associated with the Together 4 Teens breakfast and dinner and the Safe Place Holiday dinner events.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
