BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$9,000~~\$11,050~~\$14,300~~ is hereby appropriated from the Neighborhood Development Funds in the following manner: \$6,000 from District 22; and \$1,000 from District 25; \$500 each from Districts 2, 4, 7, 10, 12, 13,

14, 15, 16, 17, 20, 25; \$300 from District 1; and \$250 each from Districts 3, 5, 6, 9, 21, 23; through the Office of Management and Budget, to Junior Achievement of Kentuckiana, Inc. for curriculum materials.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
