BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO

GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$56,000~~ \$70,400 ~~\$88,000~~ from Neighborhood Development Funds in the following manner: \$11,200 from District 12; \$8,000 each from Districts 7, 23 and 24; \$6,400 each from Districts 2 and 5; \$4,800 from Districts 1, 3, 6, 10, 11, and 21; and \$3,200 from Districts 1, 4, and 9, and 17; and ~~\$1,600 from District 11;~~ and ~~\$1,600 from District 25;~~ through the Office of Management and Budget, to Commonwealth Theatre Center, Inc., for programming expenses associated with performances of "Red Riding Hood: a Vaudeville Romp."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
