A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT \$88,080 OF GRANT FUNDING FROM THE COMMONWEALTH OF KENTUCKY ENERGY AND ENVIRONMENT CABINET FOR THE APPLICATION OF A RUBBER-MODIFIED ASPHALT OVERLAY PROJECT ADMINISTERED BY THE DEPARTMENT OF PUBLIC WORKS & ASSETS.

WHEREAS, the Metro Government wishes to enter into this agreement through the Department of Public Works & Assets.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to accept an \$88,080 grant from the Commonwealth of Kentucky Energy and Environment Cabinet for the application of a rubber-modified asphalt overlay project that furthers the goals of the Kentucky Waste Tire Program by promoting development of markets for rubber-modified asphalt using waste tires generated in Kentucky.

SECTION II: This Resolution shall take effect upon its passage and approval.
