## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The amount of \$20,000 is hereby appropriated from Neighborhood Development Funds

in District 4 to Develop Louisville, Office of Advanced Planning, for expenses related to developing a

neighborhood plan for Smoketown.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for

a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
