BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$8,550~~ \$10,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 from District 15; \$1,000 from District 21; ~~\$900 from District 4;~~ \$500 each from Districts 9, 12, 13, 14, 17, and 25; \$400 each from Districts 4, 8, and 24; ~~and~~ \$350 from District 10; ~~\$250 from District 3; and \$200 from District 3;~~ to Metro Parks Department to fund the 2019 Louisville Jack O'Lantern Spectacular held at Iroquois Park and

provide vouchers for reduced admission.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
