**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,001~~ \$5,551 \$7601 is hereby appropriated from Neighborhood Development Funds, in the following manner: ~~\$2,501~~ \$2,025.50 each from Districts 9 and 16; ~~\$2,500~~ from District 16; \$500 from District 7; \$400 from District 20; \$350 from District 13; \$300 from District 8 and 14; \$250 from District 2, 6, 17, 21, 22 and 25; \$200 from

District 10 through the Office of Management and Budget, to St. Joseph Catholic Orphan Society dba St. Joseph Children's Home for security measures for the 167<sup>th</sup> St. Joe's Picnic for the Kids.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
