**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE “COUNCIL”) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$9,500~~\$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 5; \$2,500 from District 22; and \$2,000 from District 6; and \$500 each from Districts 1, 3, 4, 7, 10, 14, and 21; through the Office of Management

and Budget, to Youth Golf Coalition, Inc. for operating and programming expenses associated with providing The First Tee of Louisville's Shawnee Program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
