SECTION I: That the zoning of the property located at 1400 Hepburn Avenue containing
approximately 0.118 acres and being in Louisville Metro, as more particularly described in the
minutes and records of the Planning Commission in Case No. 19ZONE0060, is hereby maintained as
R-5B Residential Two Family.
SECTION II: This Ordinance shall take effect upon its passage and approval.
