BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$40,400~~ \$13,440 \$18,900 is hereby appropriated from Neighborhood Development Funds in the following manner: \$500 each from Districts 16, 9, 11, 23, 14, 10; \$1,000 each from Districts 6, 24, 19, 17, 15, 13, 20, 2, 18, 7, 21, 3, 8, 4, 12; \$900 from District 1; \$540 from District 12; through the Office of Management and Budget, to the Jefferson County Public Education Foundation, Inc. for supplies for the "Build

-A-Bed" Program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No. 290, Series 2011.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
