BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$43,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$25,000 from District 23; \$12,000 from District 24; \$6,000 from District 13; to Metro Parks for a summer concert series (FridayFest) in Highview Park for 2014-15 seasons.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.
