BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,550 is hereby appropriated from Neighborhood Development Funds in the following manner:  
 \$1,000 from District 15; \$750 from District 7; \$500 each from Districts 6, 10, 13, 14, 21, 25, and 26; \$250 each from

Districts 1, 4, 9, 12, 16, 17, 23, and 24; \$200 from District 3; and \$100 from District 20; through the Office of Management and Budget, to Legal Aid Society, Inc. for costs associated with the annual “Brush, Bottle and Barrel of the Bluegrass” fundraiser.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
