SECTION I: The Mayor is hereby authorized to accept \$195,000 of funding from Kentucky Heritage Land Conservation Funds for the acquisition of parcels adjacent to the Tom Wallace Recreation Area for the Jefferson Memorial Forest, to be administered by the Parks Department.
