AN ORDINANCE APPROPRIATING \$10,000\$19,000 FROM DISTRICT 7 NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$7,000 FROM DISTRICT 7, \$5,000 FROM DISTRICT 17, \$1,000 EACH FROM DISTRICTS 13, 14, 16, 20, 22, AND 23, AND \$500 EACH FROM DISTRICTS 4 AND 21, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO HONOR FLIGHT BLUEGRASS CHAPTER INC. TO PROVIDE FUNDS FOR ITS CAPITAL PROJECT AND PROGRAM EXPENSES, INCLUDING THE PURCHASE OF WHEELCHAIRS AND A SOUND SYSTEM. (AS AMENDED)

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$10,000.00\$19,000 is hereby appropriated from District 7 Neighborhood

Development Funds in the following manner: \$7,000 from District 7, \$5,000 from District 17, \$1,000

each from Districts 13, 14, 16, 20, 22, and 23, and \$500 each from Districts 4 and 21, through the

Office of Management and Budget, to Honor Flight Bluegrass Chapter Inc. to provide funds for its

capital project and program expenses, including the purchase of wheelchairs and a sound system.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended

for a public purpose.

**SECTION III:** This Ordinance shall take effect upon its passage and approval.
