**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,900~~ ~~\$6,250~~ ~~\$6,500~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 9; ~~\$500~~ ~~\$750~~ from District 10; \$300 each from Districts 5, 2, 25, 14, 21, 15, 8; \$250 each from Districts 17, 6, 16; \$200 from Districts 20, 3, 12, 13; \$100 from District 1; through the Office of

Management and Budget, to the Louisville Independent Business Alliance, Inc. for programming costs of the seventh annual Buy Local Fair 2015.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
