**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$7,000 is hereby appropriated from District 22 Neighborhood Development Funds, through the Office of Management and Budget, to C.H.O.I.C.E., Inc., for the "Dare to Dream" sports leadership and mentoring program.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
