AN ORDINANCE APPROPRIATING \$8,000 \$16,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$8,000 FROM DISTRICT 21 NEIGHBORHOOD DEVELOPMENT FUNDS; \$1,000 EACH FROM DISTRICTS 4, 8, 9, 12, AND 24; \$500 EACH FROM DISTRICTS 2, 6, 10, 14, 17, AND 25; AND \$250 EACH FROM DISTRICTS 5 AND 7; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO AMERICANA COMMUNITY CENTER, INC. TO ASSIST WITH THE OPERATIONAL COSTS OF THE YOUTH AND FAMILY EDUCATION PROGRAMS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$8,000 <u>\$16,500</u> is hereby appropriated from District 21 Neighborhood

Development Funds, in the following manner: \$8,000 from District 21; \$1,000 each from Districts 4, 8, 9, 12, and 24; \$500 each from Districts 2, 6, 10, 14, 17, and 25; and \$250 each from Districts 5 and 7; through the Office of Management and Budget, to Americana Community Center, Inc. to assist with the operational costs of the Youth and Family Education Programs.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
