**AN ORDINANCE CLOSING AN UNNAMED 6,813 SQUARE-FOOT ALLEY NORTH OF THE INTERSECTION OF WEST BROADWAY AND SOUTH FOURTH STREET AND BEING IN LOUISVILLE METRO (CASE NO. 15STREETS1008).**

**SPONSORED BY: COUNCILWOMAN MADONNA FLOOD**

**WHEREAS**, the Louisville Metro Planning Commission, as set forth in its minutes and records of Case No. 15STREETS1008, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that an unnamed 6,813 square-foot alley north of the intersection of West Broadway and South Fourth Street be closed; and

**WHEREAS**, the Council concurs in and adopts the findings of the Planning Commission in Case No. 15STREETS1008 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records.

**NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**

**SECTION I:** That an unnamed 6,813 square-foot alley north of the intersection of West Broadway and South Fourth Street and being in Louisville Metro as more particularly described in the minutes and records of the Planning Commission in Case No. 15STREETS1008 and as shown on the attached street closure plats be closed, subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
