SECTION I: The sum of \$15,500\$19,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$3,500 from District 14; \$3,000 each from Districts 13 and 25; \$1,000 each from Districts 15 and 24; \$750 each from Districts 1 and 10; \$500 from District 23; and \$250 each from Districts 4 and 6; to Metro Parks for the 2018 Riverview Independence Festival.
