**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$13,250~~ \$15,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$3,000 from District 14; \$2,500 from District 25; \$1,000 each from Districts 13, and 15, and 24; and \$750 from District 10; \$500 each

from Districts 21 and 22; and \$250 from District 6; to Metro Parks for the 9th Annual Riverview Independence Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
