**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,001~~ \$9,000 is hereby appropriated from the District 10 Neighborhood Development Funds in the following manner: \$1,000 each from Districts 10, 4, 6, 16, 17, 21, 22; \$500 each from Districts 2, 3, 5, 7; through the Office of Management and Budget, to the Family Life Center, Inc. for expenses associated with the 2015 St. Stephen Jubilee.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
