**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$20,000 is hereby appropriated from the Neighborhood Development Funds of Districts 8 and 9, through the Office of Management and Budget, to the Highland Commerce Guild, Inc., for graffiti removal and abatement program in Districts 8 and 9. District 8 appropriates \$15,000 and District 9 appropriates \$5,000.

**SECTION II:** The Council has determined that the funds requested in this Ordinance shall be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
