SECTION I: Theta Omega, Inc., local chapter of Omega Psi Phi Fraternity, Inc. is hereby recognized for its exemplary community service with the placement of honorary street signs on the southern corners of Chestnut Street and 24th Street and Chestnut Street and 26th Street to be designated as "Theta Omega Way, Omega Psi Phi Fraternity, Inc."

SECTION II: The Department of Public Works is hereby directed to move forward with the fabrication and installation of the honorary street signs upon the passage of this Resolution and the receipt of funds to cover the expense.

SECTION III: This Resolution shall take effect upon its passage and approval or otherwise becoming law.
