BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of twenty-five percent (25%) of the total project cost, not to exceed \$20,000, is hereby appropriated from the District 23 Neighborhood Development Funds, through the Office of Management and Budget, to Metro parks and Recreation to work in conjunction with

SECTION II: Metro Parks and Recreation shall not transfer the NDF to Kentucky Department of
Fish and Wildlife Resources until work on the project has started.
SECTION IIII: The Council has determined the funds requested in this Ordinance will be expended
for a public purpose.
SECTION IIIIV: This grant is subject to the Council's Policies and Procedures as adopted and
effective at the date of passage of this Ordinance.
SECTION IVV: This Ordinance shall take effect upon its passage and approval.
