ORDINANCE NO. _____, SERIES 2018

AN ORDINANCE APPROPRIATING ~~\$17,500~~15,000~~16,500~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 EACH FROM DISTRICTS 1 AND 5; ~~\$2,500~~ FROM DISTRICT 5; \$1,000 EACH FROM DISTRICTS 2, 3, 4, AND 6; \$500 EACH FROM DISTRICTS 7, 9, 10, 13, 14, 15, AND 21; AND \$250 EACH FROM DISTRICTS 12, 16, 17, 22, 24, AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO RIVER CITY DRUM CORP CULTURAL ARTS INSTITUTE, INC. FOR PROGRAM EXPENSES ASSOCIATED WITH CONDUCTING THE "SPIRIT OF THE DRUM." (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$17,500~~15,000~~16,500~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 each from Districts 1 and 5; ~~\$2,500~~ from District 5; \$1,000 each from Districts 2, 3, 4, and 6; \$500 each from Districts 7, 9, 10, 13, 14, 15, and 21; and \$250 each from Districts 12, 16, 17, 22, 24, and 25; through the Office of Management and Budget, to River City Drum Corp Cultural Arts Institute, Inc. for program expenses associated with conducting the "Spirit of the Drum."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
