**ORDINANCE NO. \_\_\_\_\_, SERIES 2016**

**AN ORDINANCE APPROPRIATING ~~\$7,250.00~~ \$11,000 FROM THE FOLLOWING NEIGHBORHOOD DEVELOPMENT FUNDS: \$1,000.00 EACH FROM DISTRICTS 8, 24, 21 AND 25; \$500 EACH FROM DISTRICTS 1, 2, 4, 5, 6, 7, 9, 12, 13, 14, 15, 16 AND 17; AND \$250 EACH FROM DISTRICTS 3 AND 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET TO EXPLOITED CHILDREN'S HELP ORGANIZATION (ECHO) INC., FOR GENERAL OPERATING FUNDS AND CHILD ABUSE PREVENTION PROGRAMMING. (AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$7,250.00~~ \$11,000 is hereby appropriated from the Neighborhood Development Funds as follows: \$1000.00 each from Districts 8, 24, 21 and 25; \$500 each from Districts 1, 2, 4, 5, 6, 7, 9, 12, 13, 14, 15, 16 and 17; and \$250 each from Districts 3 and 10; through the Office of Management and Budget to Exploited Children's Help Organization (ECHO) Inc., for general operating funds and child abuse prevention programming.

**SECTION II:** The Council has determined that the funds requested in this Ordinance shall be expended for a public purpose.

**SECTION III:** This Ordinance shall take effect upon its passage and approval.
