ORDINANCE NO. _____, SERIES 2015

AN ORDINANCE APPROPRIATING ~~\$7,750~~ \$8,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 FROM DISTRICT 15; \$1,000 FROM DISTRICT 12; \$500 EACH FROM DISTRICTS 9, 25, 3, 2, 6, 4, 21; \$250 EACH FROM DISTRICTS 13, 8, 14, 26, 1, 5, 16, 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LEGAL AID SOCIETY, INC. FOR COSTS ASSOCIATED WITH THE ANNUAL "BRUSH BOTTLE AND BARREL OF THE BLUEGRASS" FUNDRAISER (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$7,750~~ \$8,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from District 15; \$1,000 from District 12; \$500 each from Districts 9, 25, 3, 2, 6, 4, 21; \$250 each from Districts 13, 8, 14, 26, 1, 5, 16, 10; through the Office of Management and Budget, to the Legal Aid Society, Inc. for costs associated with the annual "Brush Bottle and Barrel of the Bluegrass" fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
