ORDINANCE NO, SERIES 2018 AN ORDINANCE APPROPRIATING \$8,000 \$2,500 \$2,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 2, 3, AND 21; \$500 EACH FROM DISTRICTS 4, 5, 6, 7, 9, 10, 16, 17 AND 2221; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO BRIDGE KIDS INTERNATIONAL, INCOME FOR "OUR PLACE AT BEN WASHER PARK" FOR PHASE I OF A BUILDING RENOVATION AND IMPROVEMENT PROJECT TO INCLUDE STRUCTURAL ENGINEERING TO DETERMINE THE POSSIBILITY OF ADDING A BASEMENT STORAGE AREA FOR THE BUILDING (AS AMENDED). BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METROGOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$8,000 \$2,500 \$2,000 is hereby appropriated from the Neighborhood Development Funds in the
following manner: \$1,000 each from Districts 2, 3, and 21; \$500 each from Districts 4, 5, 6, 7, 9, 10, 16, 17, and 222
through the Office of Management and Budget, to Bridge Kids International, Inc. for "Our Place at Ben Washer Park" for
Phase I of a building renovation and improvement project to include structural engineering to determine the possibility of
adding a basement storage area for the building.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
